# REPORT OF THE DIOCESE OF NEW JERSEY GENERAL CONVENTION DEPUTATION TO THE 239TH DIOCESAN CONVENTION OF THE DIOCESE OF NEW JERSEY

#### The General Convention

The General Convention of The Episcopal Church — the highest legislative body of the denomination — meets every three years to do the business of the church. It meets as two Houses: The House of Bishops, consisting of all active and retired bishops, and the House of Deputies, consisting of priests, deacons, and lay people elected by their dioceses. Every diocese can elect four lay and four clergy deputies and up to four lay and four clergy alternate deputies. Each House sits and deliberates and votes separately, although there can be joint sessions for informational purposes. Voting is by passing or rejecting Resolutions, which can state church policy, amend the Constitution or Canons of the church, or direct actions to be taken. Resolutions can only be acted upon if passed in the exact same language by each House prior to the adjournment of the Convention. Because of the volume of proposed Resolutions to be considered, much of the work of each House is done by Legislative Committees on specific subjects, whose reports on Resolutions are submitted to their House for action.

#### The 80th General Convention - 2022

Although the expectation is that General Conventions meet every three years, the 80th Convention was postponed from 2021 to 2022 as a result of the COVID-19 pandemic. Furthermore, in an effort to reduce possible contagion, (a) Legislative Committee hearings and deliberations were held by Zoom meeting for several months prior to the opening of the Convention, with only minimal meetings held during Convention, (b) Convention was reduced from ten legislative days to four, and (c) attendance was limited to bishops and four clergy and four lay Deputies plus one Alternate Deputy in each order, plus necessary volunteers and staff. All attendees were required to be vaccinated and boosted and masked and to self-administer daily COVID tests. Accommodations were made for those who had to quarantine or isolate. Attendance by Youth representatives and the Episcopal Church Women's triennial meeting were canceled.

Many members of the Deputation served on legislative committees active before, during, and some following the legislative sessions: Bishop Stokes chaired the House of Bishops Committee on Social Justice and United States Policy, and Ms. Catherine Ambos assisted as an informal secretary to that committee. In the House of Deputies, Deputy Balling was Secretary to the Committee on Governance and Structure, Deputy Mellott was Vice-Chair of the Committee on Dispatch of Business, Deputy Bach served on the Committee on Committees and Commissions, Deputy Duncan served on the Committee on Ecumenical and Interreligious Relations, Deputy Blackman served on the Committee on Social Justice and International Policy, and Deputy Ambos served on and was acting secretary to the Committee on Certification of Minutes.

This last summer's Convention acted on over 400 Resolutions. Notable accomplishments included the adoption of a \$100.5 million budget for the next two years, including new funding for resolutions proposed by the Presiding Officers' Working Group on Truth-Telling, Reckoning and Healing, including a new Episcopal Coalition for Racial Equity and Justice. Numerous constitutional amendments were passed on a first or second reading, and many canons were amended as well. # Resolution C051 — Include the name Bishop Barbara Clementine Harris in the Lesser Feasts & Fasts Calendar

This Resolution was proposed to the General Convention by Diocese of New Jersey Resolution 2022-2 — one of sixteen Resolutions proposed to commemorate Bishop Harris. The Legislative Committee on Prayer Book Liturgy & Music incorporated the text of the New Jersey proposal into one made by the Diocese of North Carolina and further amended it, and it was passed by the House of Deputies and concurred in the House of Bishops as Resolution CO23. Consequently, no further action was taken on the New Jersey proposal or the other fourteen.

## Resolution D055 — Amend Canon I.9.1 to add the Diocese of Cuba

The Diocese of New Jersey is a member of the Second Province of The Episcopal Church – The International Atlantic Province. Provinces are geographic associations of Dioceses formed for purposes of collaboration, communication, and advocacy of Diocesan and TEC goals. Up until 2018, Province II consisted of the Dioceses within the states of New York and New Jersey, the Dioceses of Haiti and the Virgin Islands, and the Convocation of Episcopal Churches in Europe. In that year the General Convention authorized the reunification of the Anglican Church of Cuba as a Diocese of The Episcopal Church, effective upon completion of revisions to its Constitution and

Canons, and accepted its request to join Province II. That process was completed in 2019, and Resolution D055 directs that it be added to the canonical list of member Dioceses of the Province. Under TEC's canons, canonical changes such as this one become effective on the January 1 following the adopting Convention.

## Resolution C021 — Amend Canon I.9.1 to change the Diocese of Puerto Rico to Province II

The Diocese of Puerto Rico had been a member of Province IX but requested a transfer to Province II. Following approval of the change by the Synods of both Provinces, <u>Resolution C021</u> also approves the transfer and authorizes amendment of the canon.

## Resolution C059 — Proposed Resolution for Provincial Synods/Councils

The 2022 Synod of Province II passed four Resolutions for submission to the General Convention. Resolution C059 proposed to have TEC allocate \$10,000 per province per year to help support Provincial activities over the next two years. This proposal was rejected by the House of Bishops.

## **Resolution C062 — Commend Gay Clark Jennings**

The Reverend Gay Clark Jennings completed at the close of the 80th General Convention her third term as President of the House of Deputies. Resolution C062, also proposed by Province II, thanked her for her service through difficult times, and it was one of the few "Privilege and Courtesy" Resolutions of this Convention not passed on the Consent Calendar and virtually the last legislation passed by both Houses.

#### Resolution C063 — Participate in Thursdays in Black

Province II's <u>Resolution C063</u> was passed, encouraging churchwide participation in the World Council of Churches' call to wear black on Thursdays as a reminder to act against gender-based violence. An article explaining the movement is here.

# Resolution C064 — Break the Silence Sunday

The final Province II submission, <u>Resolution C064</u>, designates the Sunday closest to November 25, which is the International Day for the Elimination of Violence against Women, as "Break the Silence Sunday" also to combat violence against women.

#### Elections to Episcopal Church Offices from the Diocese of New Jersey

Canon Annette Buchanan was elected to the Executive Council of The Episcopal Church, to serve until the 2027 General Convention

Canon Noreen Duncan was elected to the Board of Trustees of the General Theological Seminary, to serve until the 2024 General Convention

#### Resolutions Referred to Dioceses by the Secretary of the General Convention

For every General Convention, the Secretary of the General Convention (a) prepares a Summary of Actions listing the disposition of each Resolution brought before the Convention, (b) issues a notice to Dioceses and to Secretaries of Diocesan Conventions of proposed amendments to the

Book of Common Prayer or to the Constitution, and (c) refers selected Resolutions to Diocese (i) for action or (ii) for their consideration.

The three proposed amendments to the Episcopal Church Constitution are covered in the Report of the Secretary of the Convention, Document 8 for this Diocesan Convention. Secretaries of Convention throughout the church are required to read or otherwise make known any such proposed amendments to their Diocesan Conventions and certify back that this has been done as a condition for such proposed amendments to be eligible for a second reading for final passage.

In addition, each Diocese is required to report back to the General Convention Office what response, if any, it has made to the Resolutions referred for action or for consideration. Accordingly, these listings are included in this Report, with links to the final version of each Resolution..

#### The Next General Convention

The 81st General Convention is currently scheduled to meet in Louisville, Kentucky from June 23 to June 28, 2024, although meetings and orientation sessions will precede the first scheduled legislative session. Deputies from the Diocese of New Jersey were elected at the 238th Diocesan Convention in March 2022, and Alternates will be elected at the 239th Convention this year.

A couple of Deputies from the Diocese of New Jersey have already been appointed to serve on Interim Bodies of the Church — those Committees, Commissions, and Task Forces that carry on their mandates between General Convention and typically (a) have referred to them Resolutions from the prior General Convention for further review and consideration or (b) produce new proposed Resolutions within their fields of competence. Since the close of the 80th General Convention, Canon Valerie Balling has been appointed to serve on the Standing Commission on

Governance, Structure, Constitution and Canons, and Canon Barbara Okamoto Bach has been appointed to serve on the Task Force on Care of Creation and Environmental Racism. Emily A. Mellott had served during the 80th General Convention as Vice-Chair of the House of Deputies Legislative Committee on Dispatch of Business and is slated to serve as Chair of that Committee for the 81st.

Those of us from the 80th General Convention are thankful for having had the opportunity to serve The Episcopal Church in this capacity, and we welcome the input from the Deputation to the 81st.
