The Rev. Canon Dr. James T. Yarsiah—St. James' Church, Bradley Beach and St. Michael the Archangel, Wall



Katherine Young—St. Luke's Church, Metuchen






Rosina Dixon—St. John on-the-Mountain Church, Bernardsville

Meegan Adames—Christ Church, New Brunswick


