Persons nominated through the Secretary of Convention are marked with an asterisk. Offices with less than a full slate of candidates are highlighted.

The time periods for nominations through the Nominating Committee and the Secretary of Convention are now closed. Under the Rules of Order for this hybrid Convention, members of the Convention attending in person may make additional nominations from the floor by using the nomination slips available at the dais. For members attending electronically to make nominations from the floor, they must (a) complete an online nomination form on or before March 2 and (b) confirm that nomination during the meeting, and (c) the nominee must confirm their willingness to serve if elected.
