# The Rev. Daniel Scott Russell – The Episcopal Campus Ministry at Rutgers


Fr. Russell is very involved in the life of the diocese. He would bring a valuable point of view to the Standing Committee.

## The Rev. Henry Alan Leonard – Church of the Advent, Cape May




## \*\*Canon Barbara O. Bach - St Paul's Church, Westfield

The people of Trinity Cathedral hold a special place in my heart. I served as interim dean and later as a member of the Chapter during a complicated transition era.




Office G Standing Commission on Clerical Compensation – Clergy Vote for up to Two — 3-Year Term




## John S. Sturges – Trinity Church, Rocky Hill
